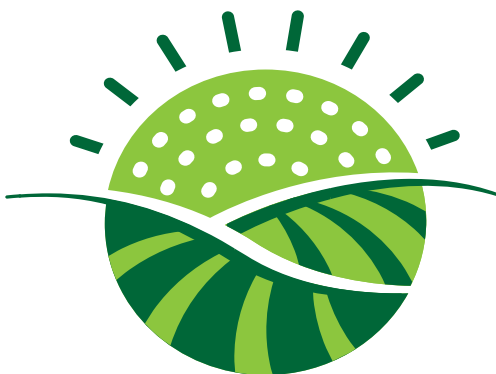

INFORMATION & CONDITIONS OF ENTRY

CONDITIONS OF ENTRY:

The Championship shall be open to any Amateur who is a male Member of a recognised Golf Club affiliated to the KZNGU recognised by the South African Golf Association, who, on the day of the Championship shall have a Handicap of 18 or less

FORM OF COMPETITION:

The Championship will be 36 holes Stroke-play off scratch, played under the Rules of Golf as approved by the Royal & Ancient Golf Club of St Andrews and the Bye-laws and Local Rules of the Dundee Country Club, all as amended by the Executive of the NKZNGA. In the event of a tie, the Championship will be decided on a 'sudden death' play off. There will also be a prize for the Best Nett score. The field shall be subject to the approval of the NKZNGA Executive, which reserves the right to refuse any entry without giving any reason for such refusal. The Executive may, at its discretion, limit the number of entries.

ENTRANCE FEE:

All entries must be accompanied by the **Entrance Fee of R320**

On no account will entrance fees be refunded unless an entry is withdrawn prior to the closing date of JANUARY 17 2019.

DRAW AND STARTING TIME:

Time of play, disputes and other arrangements connected with the Championship and Competition shall be decided by the Executive of the NKZNGA, which has the power to alter the programme at its discretion. The NKZNGA reserves the right to change the venue to another course for the event, either in part or entirely, in the case of exceptional circumstances and also reserves the right to alter the advertised times of starting. Players shall start at the time laid down by the Committee (Rule 6-3(a)). However it is a condition of this Championship that if a player arrives at his starting point, ready to play, within five minutes of his starting time, in the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7, the penalty for failure to start on time is two strokes at the first hole instead of disqualification. In addition the pace of play will be monitored and slow play can be penalised, (See Local Rules issued for this event).

OTHER CONDITIONS:

Dress Regulations set by Dundee Country Club to be worn on the course must be strictly adhered to. Competitors may only use those Golf Balls and Driving Clubs appearing in the current list of Conforming Golf Balls and Drivers and must ensure that the grooves of their clubs meet the specification in Appendix II of the Rules of Golf. Competitors **MAY NOT** drive motorised carts; Rangefinders **MAY** be used; Outside caddies **ARE** permitted

EXEMPTION OF LIABILITY:

The Host Club and Union will not be held liable for any of the following:

- 1.1 Physical and/or emotional injuries suffered during the tournament/championship, due to any acts of God, suffered as a direct result thereof, including aspects such as being struck by lightning, etc.
- 1.2 Physical injuries of any kind suffered by any person, including a player or spectator sustained by own negligence, or otherwise.
- 1.3 Emotional injuries sustained due to any loss, including death, suffered as a result of any of the above injuries sustained personally or by a spectator.
- 1.4 Damages suffered to any property of a player.

The player acknowledges the exemption of liability of the Union and its management as listed above when he signs the acknowledgement also acknowledges the contents of the above, understands it, and exempt the Host Club and Union from any liability as indicated above. The Host Club and Union does not warrant or guarantee the safety of any person.
